Introduction

Collection of Information

In order to use the My Local Mover Pty Ltd website, we may require information from you in order to provide the best service possible. All correspondence may also be collected and stored, particularly in regard to sales, support and accounts, including Email. Any information collected by My Local Mover Pty Ltd is collected via correspondence from you or your company. This may be via the telephone, Email, mail, fax or directly through our website.

Use of Collection Information

Any details collected from My Local Mover Pty Ltd customers is required in order to provide you with our products and/or services, and a high level of customer service. Correspondence is recorded in order to provide service references, and to assist in our staff development.

Storage of Collected Information

The security of your personal information is important to us. When you enter sensitive information (such as credit card numbers) on our website, we encrypt that information using secure socket layer technology (SSL). When Credit Card details are collected, we simply pass them on in order to be processed as required. We never permanently store complete Credit Card details. We follow generally accepted industry standards to protect the personal information submitted to us, both during transmission and once we receive it. Access to Collected Information

Orders

information (such as name, Email, and postal address) and financial information (such as credit card number, expiration date). We use this information for billing purposes and to fill your orders. If we have trouble processing an order, we will use this information to contact you.

Currency

All transactions are charged to your card in Australian Dollars (AUD) only.

Communications

My Local Mover Pty Ltd uses personally identifiable information for essential communications, such as Emails, accounts information, and critical service details. We may also use this information for other purposes, including some promotional Emails. If at any time a customer wishes not to receive such correspondence, they can request to be removed from any mailing lists by emailing us at movers@mylocalmover.com.au. You will be notified when your personal information is collected by any third party that is not our agent/service provider, so you can make an informed choice as to whether or not to share your information with that party.

Third Parties

My Local Mover Pty Ltd may at its discretion use other third parties to provide essential services on our site or for our business processes. Generally these involve destination agents and/or couriers involved in the shipping of your goods. We may share your details as necessary for the third party to provide that service. These third parties are prohibited from using your personally identifiable information for any other purpose. My Local Mover Pty Ltd does not share any information with third parties for any unknown or unrelated uses. We do not sell any personal or other information.

- * All transactions are performed under 128 Bit SSL Certificate.
- * All transaction data is encrypted for storage within eWAYs bank-grade data centre, further protecting your credit card data.
- * eWAY is an authorised third party processor for all the major Australian banks.
- * eWAY at no time touches your funds; all monies are directly transferred from your credit card to the merchant account held by My Local Mover Pty Ltd.
